

# Privacy Policy

We are Rawside Furniture ("Rawside"), a trading name for GSL (London) Limited, registered in England and Wales (No. 8799125).

This privacy policy (together with our Terms of Use and any other documents referred to on it) applies to Rawside Furniture. We take your privacy seriously. We will continue to invest in security and to do our utmost to protect User privacy.
